Meeting

April 27, 2021

The Jackson County Commission met April 27, 2021 in the Commission board room. Those in attendance were Vice Chairman Jason Venable, A J Buckner and Kevin McBride. County Attorney John Porter was also present and County Administrator Bob Manning recorded the minutes of the meeting. Danny Rich was absent. Chairman position is vacant.

Vice Chairman Venable noted that a quorum was present. John Porter gave the invocation and Commissioner Buckner led in the Pledge of Allegiance.

Motion to approve the agenda of the meeting and work session for April 27, 2021 was made by Commissioner McBride and seconded by Commissioner Buckner. All members voted affirmatively, motion carried.

Motion to approve the minutes from April 12, 2021 meeting was made by Commissioner McBride and seconded by Commissioner Buckner. All members voted affirmatively, motion carried.

Motion to approve hiring committee's recommendation of Matthew McCrary for the vacant Real Property Appraiser position in Mapping and Appraisal office was made by Commissioner Buckner and seconded by Commissioner McBride. All members voted affirmatively, motion carried.

Motion to approve hiring Macy Lyda as a temporary employee in the Mapping and Appraisal office was made by Commissioner Buckner and seconded by Commissioner McBride. All members voted affirmatively, motion carried.

Motion to approve hiring committee's recommendation of Kyle May for the vacant EA-1 position at Public Works department was made by Commissioner Buckner and seconded by Commissioner McBride. All members voted affirmatively, motion carried.

Motion to approve the title change from Park Manager to Parks & Recreation Director and advertise this position immediately was made by Commissioner McBride and seconded by Commissioner Buckner. All members voted affirmatively, motion carried.

Motion to accept the quote from Creted, LLC to repair floor at the building being rented to KC's BBQ was made by Commissioner Buckner and seconded by Commissioner McBride. All members voted affirmatively, motion carried.

Motion to approve the quote from Engineering and Surveying, Inc. (EASI) for engineering and design services for the Jackson County Park campsite expansion was made by Commissioner McBride and seconded by Mr. Rich. All members voted affirmatively, motion carried.

Motion to accept hiring committee's recommendations of Abigail Guzman and Joshua Clark for (2) vacant Custodial positions in Maintenance department was made by Commissioner Buckner and seconded by Commissioner McBride. All members voted affirmatively, motion carried.

Judge Manning presented a proposal for new voting machines from ES&S to replace the old Automark machines. This item will be placed on the next meeting agenda for May 10, 2021.

Vice Chairman Venable announced the appointment of Major General (Ret.) Willie Nance, Jr. by Governor Kay Ivey to serve as the Chairman of the Jackson County Commission immediately to

serve the remainder of the term of Mr. Tim Guffey. The swearing in will take place at noon, May 4, 2021 in Courtroom 1 by Judge Graham.

With no further business, motion was made by Commissioner Rich and seconded by Commissioner McBride, with all members voting affirmatively, to adjourn until the next meeting on May 10, 2021 in the Commission board room.
