RESIDENTIAL ROLL OFF CONTAINER SERVICE CONTRACT

PRICING STRUCTURE:

Roll-Off Size	Rental Rate (Flat Rate)	Time Frame	Weight Limit Per Pull	Overage Fee
10 Yard	\$250.00	3 Day Rental (weekend only)	1 ton	\$50 per ton
20 Yard	\$375.00	14 Day Rental	2 tons	\$50 per ton
30 Yard	\$425.00	14 Day Rental	3 tons	\$50 per ton
40 Yard	\$500.00	14 Day Rental	4 tons	\$50 per ton

RENTAL TERMS:

- 10 Yard – Customer will have 3 days to fill the container. Rental can be extended up to 4 extra days for \$15.00 a day. Maximum 7-day rental.
- There will be a renewal of the contract, if the container is filled within those 14 days and requires a replacement.

INCLUDES:

- On-site placement.
- Flexible dump scheduling (call-in required 24 hours in advance)
- Ideal for:
 - Renovations and Remodeling
 - Demolition
 - Large Cleanups
 - Disposing of bulky items

UNACCEPTABLE MATERIALS: (Strictly Prohibited)

- Concrete, dirt, rock, asphalt
- Stumps, brush, limbs
- Tires, Batteries, paint, oil, chemicals
- Hazardous or medical waste

Unauthorized materials will result in refusal of service and a \$250.00 handling fee.

ADDITIONAL FEES: (if applicable)

- \$75.00: Missed pull due to blocked access or overloaded container.
- \$50.00 per ton: Overweight charge beyond allowed limit.
- \$5.00 per Mattress or box spring.
- \$15.00 a day to extend.
